# Some issues of preparation, submission, evaluation and prioritization criteria for public investment project concepts for 2025

The Cabinet of Ministers of Ukraine **decides**:

- 1. To approve the Procedure for the preparation, submission, evaluation and prioritization of public investment project concepts for 2025, which is attached.
- 2. To amend the Resolution of the Cabinet of Ministers of Ukraine of November 15, 2022№ 1286 "On the Implementation of a Pilot Project for the Creation, Implementation and Functioning of the Unified Digital Integrated Information and Analytical System for Managing the Infrastructure Restoration Process" (Official Gazette of Ukraine, 2022, No. 92, p. 5738; 2023 No. 48, p. 2654) the following amendments are attached.

#### **PROCEDURE**

# for preparing, submitting, evaluating and determining criteria for prioritizing public investment project concepts for 2025

- 1. This Procedure defines the peculiarities of preparation, submission, evaluation and prioritization of public investment project concepts (hereinafter referred to as the Concept) for submission to the Strategic Investment Council established in accordance with the Resolution of the Cabinet of Ministers of Ukraine No. 549 "On the Establishment of the Strategic Investment Council" dated May 14, 2024 (Official Gazette of Ukraine, 2024, No. 47, p. 2926), proposals for a single project pipeline for public investment (list of priority public investment projects) for 2025 as part of the implementation of the transitional model of public investment management during the preparation of the draft Law of Ukraine "On the State Budget of Ukraine for 2025".
- 2. The initiators of the concept may be the key spending units or their subordinate enterprises, institutions and organizations that are determined by the key spending units to be able to implement the relevant project, provide its financial and technical support, and monitor its implementation within their authority. The information on the initiators of the concept, determined by the key spending units, shall be entered by the key spending units into the Unified Digital Integrated Information and Analytical System for the Management of the Process of Reconstruction of Immovable Property, Construction and Infrastructure, established in accordance with the Resolution of the Cabinet of Ministers of Ukraine No. 1286 of November 15, 2022 "On Implementation of the Pilot Project on the Creation, Implementation and Functioning of the Unified Digital Integrated Information and Analytical System for the Management of the Process of Reconstruction of Immovable Property, Construction and Infrastructure" (Official Gazette of Ukraine, 2022, No. 92, p. 5738; 2023 No. 48, p. 2654) (hereinafter referred to as Unified Digital System).
- 3. Concepts are being prepared for both new projects and those already underway that will require funding from the state budget (including funds from international financial organizations and foreign governments) or state support (state guarantees, etc.) in 2025, as well as for public-private partnership projects.

- 4. The initiator creates a concept by filling in the relevant information in accordance with Annex 1 through the functionality of the Unified Digital System in a separate block "Concepts" in the user's account in the Unified Digital System, which is created at the request of the key spending unit.
- 5. Concepts are submitted and reviewed through the Unified Digital System in accordance with its regulations and are confirmed by the initiator's authorized person by applying a qualified electronic signature or an advanced electronic signature based on a qualified electronic signature certificate.
- 6. If the initiator identifies inaccuracies/inconsistencies in the concept before the deadline for acceptance of concepts, the initiators may eliminate the identified inaccuracies/inconsistencies. No changes to the concept may be made after the deadline for accepting concepts.
- 7. Evaluation and prioritization of concepts is carried out through the Unified Digital System based on the defined prioritization criteria and their weighting coefficients in accordance with Annex 2.
- 8. The Ministry of Economy, the Ministry of Finance, and the Ministry of Infrastructure evaluate the concepts and provide relevant conclusions in accordance with their respective powers, in particular:

The Ministry of Economy - in terms of strategic feasibility (compliance with national and sectoral strategies) and socio-economic feasibility (assessment of social and economic impact, population coverage, etc;)

The Ministry of Finance - in terms of financial feasibility (assessment of financial capacity and affordability);

The Ministry of Infrastructure - in terms of compliance with the strategic goals and priorities of the State Strategy for Regional Development of Ukraine, technical (infrastructure) and institutional capacity (assessment of operational readiness, energy efficiency, implementation capacity, etc.)

The evaluation results are generated automatically in the Unified Digital System, and the conclusions are confirmed by authorized persons of the Ministry of Economy, the Ministry of Finance and the Ministry of Infrastructure by applying a qualified electronic signature or an advanced electronic signature based on a qualified electronic signature certificate.

- 9. Based on the information provided in the concept by the initiator and the conclusions of the evaluation conducted by the Ministry of Economy, the Ministry of Finance and the Ministry of Infrastructure, the Unified Digital System automatically calculates the total score for each concept, taking into account the weighting coefficients which the concept complies.
- 10. A prioritized list of concepts based on the scores is formed separately for each sector.

- 11. The Ministry of Economy summarizes the information on the results of the assessment and submits it to the Strategic Investment Council for consideration.
- 12. The information on the score received will be available to the initiator of the concept after the evaluation is completed.
